JACKSONVILLE, FL (November 14, 2022) – *Northeast Protection Agency, LLC.*, announced today it has expanded its operations into the State of Florida where it has launched *Proteus Protective Services*, a full-service licensed (B-3200553) armed and unarmed security patrol firm. Proteus will provide uniformed officers to residential apartment management companies, motels, shopping plazas, schools, restaurants, and other commercial establishments. Sometimes, there are just not enough resources for an agency to respond to some calls, and that's where professionally managed security firms can both directly and indirectly pick up some of the slack by taking their clients' calls for assistance."*

Sean Saunders, Proteus' Deputy Chief commented: *"In regard to certain apartment complexes and motels, it is well-established that they have proved to be an ongoing drain on law enforcement resources and a source of chronic problems in many communities, especially those adjacent to the Duval/Clay county line. We're going to focus on that sector, working closely with pro-active management in a unified effort to reduce crime that will provide local residents with a better quality of life."*

Proteus will also focus on supporting U.S. Department of Housing and Urban Development (HUD) managed multifamily housing where federal policy mandates management maintains a complement of full security and policing services such as patrol, guarding, investigations, etc. *"The core mission of federal public housing authorities includes creating strong, sustainable and safe communities at their HUD-assisted multifamily developments, and the only way this can be achieved, is with being assertive with chronic security issues that must be addressed,"* said Maj. S. Scott Alfassa, Proteus' Director of Strategic Initiatives.
